FEES AND CHARGES 2022 TO 2023

Detailed below are the fees effective from Michaelmas Term 2022

The above fees represent an annual charge apportioned equally over three terms. Where appropriate they recognise periods of home study and no adjustment is available in respect of this, or of variations in the length of terms where, inter alia, pupils do not attend for the whole year.

The above fees include swimming where applicable and lunches. If a pupil requires one third of a pint of milk in the morning break, the charge will be £18.00 per term.

The discounts allowed for those who have two or more children in the school simultaneously (Nursery being disregarded for this purpose) will be as follows:

For the 2nd child	7%	} of the fees of those children
For the 3rd child	15%	
For the 4th & 5th children	20%	

The fees do not include:

- (a) Minibus service to and from School/Home for which a separate scale of charges applies.
- (b) Music Tuition (optional) for which a separate list of Charges & Conditions apply. Half hour individual lessons are charged as follows for the 2022/23 year:

- (c) Additional tuition in subjects outside the normal curriculum timetable.
- (d) Educational visits. Transport using school coaches will be free. Entry fees and costs of hire coach (if needed) will be charged in arrears as disbursements. Optional excursions are not included.
- (e) Occasionally examination text books are purchased by pupils.
- (f) Examination fees for A Level & GCSE entries, English Speaking Board Examination entries (years 3, 4, 5 and 6 only), and any music examinations.

- (g) School photograph (optional).
- (h) Pupils may be required to provide certain items of equipment as advised to parents from time to time.
- (i) Other optional extras, the charges for which will be made known from time to time.
- (j) Extra tuition or support for individual pupils*

This list is for information and is not exhaustive.

The table below shows additional fees, where appropriate, for a pupil with a Special Educational Need or Disability beyond the level support which the school deems reasonable within the normal school fees. Where pupils qualify for nursery grant this will be deducted from the fees payable. Any hours utilised over and above eligible funded hours will be charged at £5.90 per hour.

Where children are attending a session that spans lunchtime, lunch will be charged at £3.00 per day. Other snacks and drinks will be supplied free of charge.

The following are fees for Nursery sessions where no funding is available.

The fees are due in advance, in full on the first day of term. Interest will be charged on overdue accounts at 8% p.a. over base rate. **Details of a fee funding scheme will be provided on request.**

Fees are payable by BACS (Bank account details are displayed on fee bills). Parents wishing to pay in cash should ask for a paying-in slip as cash cannot be taken under any circumstances.

A full term's notice in writing is required of the intention to remove a child from the school or to discontinue any optional extra, otherwise one term's fees are due in lieu of such notice.
